## 1. Apologies

Apologies were received and accepted from Mrs S Wood, Mr I Hay, and Mr R Summerfield Cllr Wooles, Vice Chair, took the Chair in Mrs Wood's absence.

### 2. Public Session

There was no public session with no members of the public attending.

## 3. Minutes of Meeting held on 18 June 2015

Minutes of the meeting held on 18 June which had previously been circulated were agreed, with the insertion of payment amount of £650 previously omitted for repair work and painting of playground fencing, and duly signed as a true record.

## 4. Matters arising from meeting held on 19 May 2015 which are not on the agenda

It was agreed that discussion of newsletter and website advertising would form part of the next finance group meeting.

### 5. County and City Councillor Reports

County Cllr Phil Bailey highlighted four areas

- School: Admission discussions were ongoing with data showing another potential high number of in catchment children in the academic year 2018/19
- Grants: Community Project Grants were available until 8 September
- Footpaths: A new interactive map for reporting problems on public rights of way was being launched
- Hampshire highways teams were featuring in a six week Channel 5 documentary series, which started on Monday 13 July, Stop! Roadworks Ahead

City Cllr Caroline Horrill referred to items in her written report (circulated following the meeting):

- Boundary Changes: The Local Government Boundary Commission for England had recommended that Sparsholt become part of a three councillor ward called Wonston & Micheldever incorporating the parishes of Crawley, Micheldever, Sparsholt and Wonston, and part of the parishes of Littleton & Harestock and South Wonston. Currently there were five councillors covering this area with the new electoral arrangements expected to come into force at the local elections in 2016.
- Barton Farm remained part of Headbourne Worthy Parish Council but may in the future become a separate Parish Council. For residents of Sparsholt the traffic impact of Barton Farm was probably most relevant in the longer term.
- Community Project Grants (as above).
- Planning and Enforcement (ref Item 8).
- Silver Hill: Winchester City Council had taken several key decisions moving the Silver Hill project to the next stage. These were based on the developer's decision to proceed with 2009 planning

permission and took into account viability re the affordable housing provider, funding provider and overall financial viability of the scheme.

#### Reviewed

15/01163/LDP Woodland Barn: Following further information relating to "Certificate of Lawfulness" and "General Permitted Development" it was resolved to withdraw the Parish Council's support for this application. Councillors now understand that the dwelling has not been completed to the stage at which "General Permitted Development" rights can be considered.

### New application

- 15/01424/FUL Cuckmere (RETROSPECTIVE) Change of use of part of outbuilding to 1.no bed holiday let: It was agreed to object to this retrospective application of change of use of part of outbuilding to a 1no bed holiday let.
  - The outbuilding referred to is deemed to be a separate dwelling (The Hayloft) and thus contrary to planning policy for a new dwelling in the countryside.
  - The recent Watley Granary (15/01075/FUL) decision to permit conversion of outbuilding to form ancillary accommodation was noted with the condition that this should only be used for purposes ancillary to the residential use of the existing dwelling.
