1. Apologies

Sparsholt Memorial Hall – Cllr Summerfield had provided a report (Annex E). Councillors discussed the ongoing issue of the piano. Attempts to donate free to a good home (subject to removal) or donate to a musical/educational institute had not succeeded. Cllr Horrill suggested that one of the entrepreneurial homeless charities in Winchester may be willing to take the piano and utilise to raise funds.

Police Liaison

PC Croutear highlighted the website https://www.police.uk/ where local crime statistics could be obtained. 10. To consider a report from the Anaerobic Digester Working Group

The working group recommended that Sparsholt Parish Council object to planning application **16/00116/FUL.** Detailed investigation had been carried out including expert advice from both planning and transport experts in reaching this conclusion. A public meeting had been held to inform attendees and to listen to views expressed both in support and objection to the application.

On behalf of Cllr Annesley the clerk reported that the second part of the Parish Plan questionnaire covering all aspects of life in the village was due to be distributed along with both the Parish Newsletter and Church magazine towards the end of March.

- 15/02312/FUL Land At Junction of Woodlands Lane and Church Farm Lane Improvements to
 existing access from Woodman Lane to Church Farm Lane, including alterations to visibility splays –
 application permitted
- **15/02922/FUL** 1 Lambourne Close One and half storey extension to front and side, recladding to existing conservatory and associated alterations application permitted
- 15/02876/LDP Meadowview Hillside Road (CERTIFICATE OF LAWFULNESS) Internal alterations to convert 3 no. studio flats to 2 no. 1-bedroom flats on the ground floor of an existing two storey building – application permitted
- 16/00065/FUL & 16/00066/LIS Corner Cottage Woodman Lane Sparsholt Demolish existing poor
 extensions and erect two storey subservient extension to improve facilities for disability purposes and
 new garage block. (AFFECTS THE SETTING OF A LISTED BUILDING) application refused

- **15/01678/FUL** Balldown Business Centre Extension of existing external storage areas and distribution roads.
- 16/00133/FUL Sparsholt College Westley Lane Sparsholt Single storey glazed extension to existing 'Bytes' Dining Room.

Current Applications

16/00116/FUL Sparsholt College Westley Lane Sparsholt Biomass-based anaerobic digestion plant including: 3 No. digesters (2 No 'primary', 1 No. 'secondary'); 2 No. digestate storage tanks; biomethane upgrading plant; biogas boiler; standby flare stack; weighbridge & marshalling yard; agricultural feedstock storage (silage clamps); biomass pre-treatment hall; 2 No. buffer tanks (liquid substrate & silage effluent storage); digestate separation station; office, electrical and control building; ground works including bunding and reprofiling using excavated materials; surface water storage

lagoon; hard surfacing; means of enclosure; landscaping; alterations to an existing access to Westley Lane; and an education building (Use Class D1) for the 'Hampshire Centre for the Demonstration of Renewable Technologies'.

It was unanimously agreed to object to this application. The letter attached to these minutes giving reasons was agreed and would be hand delivered by the Chair on Friday 18 March.

- 16/00170/FUL Downs Cottage Woodman Lane First floor front extension and two-storey side and rear extension
 - SPC had supported previous application 15/02585/FUL and thus supported this revised application which was smaller than the previous refused application. **Action: Clerk**
- **16/00295/FUL** Woodlands Hamgreen Lane Swimming pool (ancillary to Woodlands Barn) The Chair had visited the site and described the proposal to councillors. It was agreed to support but with conditions
 - The swimming pool be appropriately fenced to ensure the safety of children and animals
 - The intensity and direction of any associated external lighting be installed so as not disturb others

- 16/00336/LDC Shedding Oaks Cattery Ham Green Existing Use of the dwelling house The Chair had visited the site and described the resident's application. It was agreed to support the application to remove the agricultural clause associated with the property. It was understood that the land has not been farmed for some 30 years. **Action: Clerk**
- 16/00451/FUL Balldown Farm House Northwood Park Replace existing car port with new oak framed garage

As a replacement building this application was supported.

It was noted that WCC was trialling a new paperless parish consultation system whereby plans would be available on line only.

13. Finance

 - Annex C had been circulated in advance of the meeting. Payments PV62 to PV74 were approved.
- **Budget Update**
 - Annex D had been circulated in advance of the meeting and incorporated payments and amounts set aside in respect of funding advice and expenses associated with planning application 16/00116/FUL: Sparsholt College Westley Lane Sparsholt Biomass-based anaerobic digestion plant and education building as previously approved.
- The Clerk reported that her understanding of the new arrangements for the accountability and audit of local public bodies in England was that from the financial year 2017-18

Internal Audit

- SPC continues to appoint an internal auditor
- **External Audit**
 - SPC opts into the SAAA (Smaller Authorities' Audit Appointment Limited) arrangement by nothing
 - SPC qualifies for an exemption from external audit (turnover of £25,000 or less) unless event of special circumstance or if an elector raises a question that requires audit

It was agreed that SPC would do nothing thereby opting into the SAAA arrangements. The clerk was asked to check qualification and experience criteria for internal audit. **Action: Clerk**

On Wed 16th March the public Consultation begins on to seek views on how savings can be made in the cost of Running Hampshire Waste Recycling Centres.
