The Department plans to lay the necessary legislation to enact many of the remaining reforms announced in BEIS' Government Response of December 2016 later this year"

Cllr Wood had met with the WCC case officer to understand more about this application and had updated councillors ahead of the meeting by email.

It was noted that access to the storage site would pass the children's nursery and residential dwellings until such time the Anaerobic Digester was built.

As the application was from Ecotricity the College had also been contacted to ensure its support with the reply that "to demonstrate a reasonable size of energy storage facility is part of our range of energy efficient and renewable technologies as part of the Centre for the Demonstration of Renewable Technology which we have been and continue to develop around the college".

It was agreed to support the application recognising energy storage as a key element of renewable technology but to request that conditions be applied to ensure that traffic movement past the nursery be restricted to avoid drop off and pick up times.
